

**MUNICIPALITY OF CLANWILLIAM-ERICKSON  
BY-LAW NO. 17/15**

BEING A BY-LAW OF THE MUNICIPALITY OF CLANWILLIAM-ERICKSON TO PRESCRIBE FOR DISCOUNTS FOR PREPAYMENT OF TAXES AND THE PENALTY ON UNPAID TAXES.

**WHEREAS** Section 344 of the Municipal Act provides as follows:

344 The council may by by-law allow a discount subject to any limitation prescribed by the Minister by regulation, for the prepayment of taxes on or before a date specified in the by-law.

**AND WHEREAS** Section 346(2) provides:

346(2) A Council may by by-law  
(a) set a rate, subject to any limitation prescribed by the minister by regulation, at which penalties may be imposed in respect of tax arrears; and  
(b) impose penalties at that rate.

**AND WHEREAS** Section 346(3) provides:

346(3) ...a penalty... may be imposed at the beginning of the month whether or not the tax arrears are paid at any time during the month.

**NOW THEREFORE BE IT AND IT IS HEREBY ENACTED** as a by-law of the Municipality of Clanwilliam-Erickson in Council duly assembled as follows:

- (1) **THAT** taxes levied for the current year shall be deemed to be due and payable on or before October 31 of that same year.
- (2) **THAT** commencing in 2015 and continuing in each and every successive year Municipality of Clanwilliam-Erickson shall hereby allow discounts on prepayments of all current taxes at the following prescribed rates:

June	- Two percent (2%)
July	- One and one-half percent (1 ½%)
August	- One percent (1%)
September	- One half percent (½%)
October	- Payable at par
- (3) **THAT** the Municipality of Clanwilliam-Erickson shall impose a penalty at a rate of 1 ¼% per month on all taxes remaining unpaid on the first day of November and the first day of each month thereafter.
- (4) **THAT** By-Law No. 1446-02 of the Rural Municipality of Clanwilliam is hereby repealed.
- (5) **THAT** By-law No. 543/03 of the Town of Erickson is hereby repealed.
- (5) **THAT** this by-law shall come into force on the final reading thereof.

**DONE AND PASSED** as a By-Law of the Municipality of Clanwilliam-Erickson at Erickson, Manitoba in the Province of Manitoba this 22<sup>nd</sup> day of April, 2015.
