**Regarding SPECIAL SERVICE PLAN #29-16
For Curbside Pickup of Household Waste in the urban ward of the
Municipality of Clanwilliam-Erickson
BY-LAW NO. 29/16**

(Pursuant to Subsection 314 of the Municipal Act)

The Council of the Municipality of Clanwilliam-Erickson has scheduled a public hearing at the municipal Office in Erickson, MB (45 Main Street) on the **24th of February, 2016 at 9:15 a.m.** to present the following special service plan which was created by council.

1. DESCRIPTION OF THE SPECIAL SERVICE

The Special Service Plan proposed herein involves the curbside waste collection from residences, trailer parks, and commercial establishments including otherwise exempt properties within the urban ward of the municipality. The Special Service Plan excludes vacant lots and Railway Property (Class 52).

2. POTENTIAL TAXPAYERS UNDER THE PLAN

Potential taxpayers are all property owners with residential properties within the urban area of the municipality, as listed on Schedule "B" which can be obtained at the municipal office or the municipal website at: www.ericksonmb.ca.

3. METHOD AND RATE OF CALCULATING THE SPECIAL SERVICE TAX

The Special Service Tax to be charged under this proposal is to be calculated on an amount per parcel of land.

2016 total annual cost of \$31,440.00 and the levy will be as follows per property:

Mobile Home Park.....	\$241.30

2017 total annual cost of \$33,012.00 and the levy will be as follows per property:

2018 total annual cost of \$34,663.00 and the levy will be as follows per property:

2019 total annual cost of \$36,396.00 and the levy will be as follows per property:

Residential.....\$127.69
Commercial.....\$185.57
Residential Large.....\$278.18
Mobile Home Park.....\$279.34

Funds generated by this special levy, \$36,397.16

2020 total annual cost of \$38,215.50 and the levy will be as follows per property:

Residential.....\$134.08
Commercial.....\$194.85
Residential Large.....\$292.09
Mobile Home Park.....\$293.31

Funds generated by this special levy, \$38,217.02

A written objection may be filed with the Chief Administrative Officer, at 45 Main Street, Erickson, MB prior to the commencement of the hearing. At the hearing, Council will hear any potential taxpayer who wishes to make a presentation, ask questions or register an objection to the special service plan.

All objections, written or verbal, must be filed prior to the adjournment of the hearing and must include the name, address and property description of the person filing the objection and the grounds of their objection. Note that as per The Municipal Act if less than 2/3 of the affected ratepayers object, the Special Service plan will go forward as planned.
