## The Delegation reported on:

- Increased costs of delaying funding on the airport paving project;
- If an airstrip is closed, the cost to paint mandatory markings on the runway will be approximately \$40,000;
- The project can be funded through Gas Tax;
- The ICIP money can only be used for the airport;
- The hangars have value as taxable property;
- There is interest in constructing more hangars if the runway is resurfaced;
- Airplanes are getting damaged due to the runway's condition currently;
- STARS and spray planes, and many others currently use the airport;
- Conversion to a grass strip, or reduced runway length would reduce the number of planes that can use the airport;
- Re-paving the runway to the full length of 3000' is desirable;
- Local residents have moved on to have a career in flying due to early exposure to the airport. Others moved here specifically because of the airport;
- Grass runways are unusable during spring breakup and wet weather, which is the same condition that lends itself to requiring spray planes on fields:
