Committee: Four Winds Board

Meeting Date & Location: August 02, 2018 new landfill site

**SUMMARY:** The MLA Greg Nesbitt requested a meeting with Lloyd Ewashko and myself at the landfill site. We attended and there was a group of landowners there with Craig MacDonald from the provincial government. We had a 3 hour discussion regarding the project and then had a tour of the drainage areas around the landfill site

Committee: Little Saskatchewan River Conservation District Meeting Date & Location: August 03, 2018 Shoal Lake

**SUMMARY:** This is the first group meeting of the 3 conservation districts that are being amalgamated. Went through a long agenda of all the different aspects of the amalgamation, and resolved many of the issues. Each agreement will be presented to provincial officials for endorsement later in September. In six hours we had lively debate. The things we couldn't agree on or needed clarification were assigned out to sub groups for them to report back. The biggest issues revolved around municipal levies and transition funding from the province. The date for proclamation of the legislation is January 2020 with amalgamation happening soon after.

Meeting Date & Location: August 03, 2018 - Erickson

**SUMMARY:** Conference call with Neegan Burnside to discuss their participation in the upcoming public information sessions. We will design some sign boards that they will produce and we will try to have a private session with the 7 local residents from the landfill site during the more formal public information sessions. Neegan-Burnside will also produce foam board displays that I will design the first draft and the group will adjust for the final version.

Committee: MMSM and Rolling River First Nation (landfill)

Meeting Date & Location: August 10, 2018 RRFN

**SUMMARY:** As part of the agreement with Rolling River First Nations (RRFN) and the landfill is that they start a recycling program to minimize their impact on the landfill. I facilitated a meeting between MMSM and RRFN to start that process and have them evaluate how best to deliver the program and integrate the two systems. There is also paperwork that needed to be filled out and filed with the province to register RRFN as a recycler. Meeting went well and am now working on an agreement document between RRFN and the South Mountain Waste Recycling Group (recycling partnership).

Meeting Date & Location: August 13 Sandy Lake

**SUMMARY:** The interim board of directors of the group met to start working on a by-law that will be rules that the committee will abide by. We have used a number of examples from other landfills to start writing a by-law. The major details still need to be worked out but philosophically, we seem to be reasonably close.

**SUMMARY:** Attended a funeral for a band member and was thanked by the Chief and Council for attending and shared condolences from Clanwilliam-Erickson

Committee: Services to Seniors

Meeting Date & Location: August 16. Onanole

**SUMMARY:** There were a number of issues. The building where the office is has been sold and a new lease was reviewed by the board and resolved to sign. We reviewed the Resource Coordinator evaluation for last year which is a requirement set by the RHA as a grant condition. Reviewed and approved by the board. Looked at upcoming fund raising functions including raffle, Music Concert and Harvest Tea. These will occur this fall.

Committee: South Mountain Waste Management Group (smwmg)

Meeting Date & Location: August 20, Erickson

**SUMMARY:** Major discussion was about integrating rrfn into the recycling program and items that need to be included into the agreement. There were also discussions about issues raised by MMSM at the previous meeting and the provincial participation in the recycling program. No additional pests at the recycling station and so far loads have not slowed down for the end of summer.

Meeting Date & Location: August 20, Erickson

**SUMMARY:** Final conference call with Neegan-Burnside and Indigneous Services Canada regarding the upcoming Public Information Sessions regarding the regional Landfill. We had to finalize the logistics for the meetings, finalize the foam informational boards, and review potential questions and issues that may arise.

Committee: Water and Sewer Committee

Meeting Date & Location: August 20, Erickson

SUMMARY: Progress meeting on the sewer study that is being carried out by Stantec Engineering, after having two emergency releases of the lagoon. We discussed progress to date and the review of existing system. Discussed potential infiltration sites in the system and what needed to be filmed to evaluate. We also had a leak near the lagoon that was spilling into the ditch, we reviewed what actions we had taken, what the Province was requiring us to do and what the potential cause for the leak was. Appeared to be a plugged line near the lagoon and required flushing. Need to address the amount of grease allowed into the system. Finally we reviewed actions still needed to complete the contract with Stantec including measuring sludge in the cells, forcing additional drawdown during releases, and the potential for adding a splash pad to accommodate septage trucks.

Committee: Little Saskatchewan River Conservation District

Meeting Date & Location: August 21, Erickson

**SUMMARY:** Spent the morning collecting water samples from local residents to be tested in Winnipeg to assure water quality of local wells. There were 22 samples taken which is slightly down from the previous year. Overall, samples were slightly down across the district. There were 148 samples taken.

Meeting Date & Location: August 22 Sandy Lake

**SUMMARY:** First Public Information Session regarding the regional landfill. About 75 people attended. There were numerous questions about the environmental issues, the process about how we got to this point, Numerous extremely rude people that were very passionate about the landfill not being situated near their homes. The group including engineers from Neegan-Burnside attended and dealt with the questions and verbal assaults.

**SUMMARY:** That evening we had a Public Information Session in Erickson for our municipality residents and Rolling River residents. About 13 people attended and it seemed to be accepted as a reasonable approach. People were respectful

**SUMMARY:** We knew that there is a small group of local residents that have a special interest in where the landfill will be sited. We offered and they accepted a private meeting with Neegan-Burnside engineers to tour and discuss the site. We met onsite and the discussion went fairly well but degraded into threats and insults by the residents of the committee and engineers. Seemed counterproductive but at least they got to vent, there was no new information presented.

Meeting Date & Location: August 23, Onanole

**SUMMARY:** Public Information Session that we held in Onanole. Many of the same outspoken people from Sandy Lake came to this session. There were around the same number of people around 75. Many people supported the increased recycling aspect of the project and took issue with the outspoken members and argued with them on our behalf. The session went fairly well.

Committee: Riding Mountain Biosphere Reserve Meeting Date & Location: August 30, Erickson

SUMMARY: The focus of this meeting was on aquatic invasive species (ais) namely zebra mussels. The group reviewed what had occurred in Sandy Lake and the continued efforts to establish a decontamination site in the region. There were also discussions on soil health and future efforts to change practices to sequester carbon and improve moisture holding ability of soil. Numerous people from the Ditch Lake community attended to see what they could do to protect Ditch lake from ais in the future. The next issue the group wants to tackle is river and lake water quality. There is no plan as yet but are inviting the citizen science coordinator from the province to come and speak with us about setting up a water testing group for the area.
